## Pool Rules 2018

Yellow Indicates New or Updated Rules

1. Pool hours are from 6:00 am to 10:00 pm or dark, whichever occurs first.
2. There are **NO** lifeguards on duty. All persons use the facilities at their own risk.
3. All residents and guests **MUST** sign in. A maximum of 5 guests per HOA resident household per day. Guests must be accompanied by a resident adult 18 years of age or older. Expecting additional family or guests? Visit the office for a Resident Guest Pass (\$50.00 plus a refundable \$25.00 key deposit) good for up to 10 guests for seven days.
4. Children under the age of 12 must be supervised by an adult resident or appropriate caregiver 18 years of age or older.
5. **NO** nudity is allowed in the pool or on the pool deck, this includes children. Swimsuits or other appropriate swimwear is mandatory while in or at the pool. No street clothes.
6. Swimmers not or recently toilet trained or incontinent **MUST** wear a swim diaper **AND** rubber swim pants that fit snugly at the waist and legs with their bathing suit. Disposable diapers are not allowed. Diapers must be changed in the bathroom facilities, not poolside or on a poolside table or chair.
7. Showers are required before entering water.
8. Use of the South Meadow Wading Pool (aka the mushroom pool) is limited to children 5 years old and under.
9. ALL swimmers **MUST** exit the pool at 3:00 pm and 7:00 pm for a 15 minute break **for safety inspection and water testing. ALL swimmers MUST** exit the pool until the Pool Monitor signals inspection and testing is complete.
10. **NO** diving. **NO** running. **NO** roughhousing. **NO** jumping from mushroom pool to larger pool.
11. **NO** foul language, rude or discourteous behavior.
12. **NO** hanging or jumping on the lane lines, or diving from the starting blocks.
13. **NO** smoking or **vaping** inside the pool area or on the pool grounds.
14. **NO** inflatables, rafts or pool toys larger than 36". **NO** water guns.
15. **NO** glass bottles or containers.
16. **NO** standing or jumping on pool furniture.
17. **NO** chewing gum. **NO** chewing gum. **NO** chewing gum.
18. **NO** alcohol permitted in the pool area [except] Adult Swim Nights, at which time cans or plastic containers are permissible.
19. **NO** pets allowed in the pool area except Service Animals.
20. **NO** wheeled toys, bikes, wagons, scooters or skateboards are allowed on the pool deck. Strollers with locking wheels are permitted.
21. **NO** food is allowed in the pool or on the pool deck except in designated areas. [Clubhouse pergola, South Meadow pergola]
22. Pool monitors are empowered by the HSTA to clear the pool if unsafe conditions occur [biological incident, lightening, equipment failure], enforce the rules and the authority to ask a resident(s) to leave the pool area if warranted. An incident report will be completed for every violation and submitted to the Town Association. Please see **Pool Incident Procedure**, page two.



## Pool Incident Procedures

The pools are for the pleasure of every resident and rules are in place to insure the fun, enjoyment and safety for all.

In the event that the rules are intentionally not followed and disregarded, the pool monitors and pool monitor supervisors are empowered by the HSTA to ask residents to leave the pool area. An incident report will be completed for **EVERY** violation and submitted to the Town Association.

### **Procedures**

**Level One / Incident One** – Resident asked to leave the pool area for the remainder of the day. Pool Incident Report completed and turned into the Town Manager. If the resident is under the age of 18, the parent/guardian will be contacted.

**Level Two / Incident Two, Failure to Comply and/or Harassment of a Pool Monitor** – Resident asked to leave the pool area for the remainder of the day by the Pool Monitor Supervisor. Pool Incident Report completed and turned into the Town Manager. **Community Access Card Privileges revoked for 7 days.** If the resident is under the age of 18, the parent/guardian will be contacted.

**Level Three / Incident Three, Failure to Comply and/or Harassment of the Pool Monitor Supervisor** – Resident asked to leave the pool area for the remainder of the day by the Pool Monitor Supervisor and/or Town Manager. Pool Incident Report completed and turned into the Town Manager and Town Council. **Community Access Card Privileges revoked for 30 days.** If the resident is under the age of 18, the parent/guardian will be contacted.

**Level Four / Incident Four, Harassment of the Pool Monitor or Supervisor requiring the immediate presence of the Town Manager, a Town Council Member or the Sheriff** – Resident asked to leave the pool area for the remainder of the day. Incident report completed and turned into the Town Manager. **Community Access Card Privileges revoked for 60 days.** If the resident is under the age of 18, the parent/guardian will be contacted. Also, per Association Policy 800 / Facilities Incident Policy, the Town Council will review and determine if any further action is warranted.

**Level Five (biological)** – If a pool requires closure due to the violation of Rule #6, the resident responsible will be subject to a \$100.00 fine.
