


## POOL RULES / SWIM AT YOUR OWN RISK (Updated 5/8/24)

- NO lifeguards are on duty. All persons use the facilities at their own risk.
- ALL swimmers must take a cleansing shower before entering the water.
- **Persons with an infectious or a communicable disease** that can be transmitted by water, may not use the pool.
- Pool Facilities are for Hidden Springs home owners, and their invited guests only. Limit of 5 guests per household. All Guests must be accompanied by an owner or adult member 18 years or older. Children under the age of 12 must be accompanied by an adult member 18 years or older.
- NO nudity is allowed in the pool or on the pool deck, this includes children. Swimsuits or other appropriate swim-wear is mandatory to swim in the pool.
- Swimmers not or recently toilet trained or incontinent **MUST** wear a swim diaper **AND** rubber swim pants that fit snuggly at the waist (no disposable diapers) and legs with their bathing suit. Diapers must be changed in the bathroom facilities.
- The wading pool (at South Meadow) is for children 5 years old and under.
- NO diving. NO running. NO roughhousing.
- NO foul language, rude or discourteous behavior.
- NO hanging or jumping on the lane lines, or diving from the starting blocks.
- NO smoking or vaping inside the pool area or on the pool grounds.
- **NO** inflatables, rafts or pool toys larger than 36". **NO** water guns. **NO** water balloons.
- NO glass bottles or containers.
- NO alcohol.
- NO standing or jumping on pool furniture.
- NO chewing gum and NO food in the pool except at tables under pergolas.
- NO pets in the pool area except Service Animals with ID and vest. Owners are responsible
  for the animal's behavior at all times.
- NO wheeled toys, bikes, wagons, scooters or skateboards are allowed on the pool deck.
   Strollers with locking wheels are permitted.

The pools are for the pleasure of every member and/or resident and the rules are in place to ensure the fun, enjoyment and safety of our neighbors.





## POOL INCIDENT PROCEDURES

The pools are for the pleasure of every resident and rules are in place to insure the fun, enjoyment and safety for all.

For community success with self-monitoring at the pools, review the pool rules and share them with minors headed unaccompanied to the pool. Rules and reminders are posted at the pools and are helpful as a point of reference when faced with a "forgetful" pool user.

In the event that the rules are intentionally not being followed and disregarded, members and/or residents may complete and turn in a Pool Incident Report to the Town Office. Incidents verified by multiple members and/or residents (signature and contact information included) or evidenced upon review of security camera, will result in further action by the Town Manager and/or Town Council as noted in Association Policy 800 / Facilities Incident Policy.

In the event the immediate presence of the Town Manager or Assistant Town Manager is required at the pool to address unsafe behavior(s), bullying or harassment, the resident will be asked to leave the pool area and may result in the loss of pool privileges for the season. If a resident is verbally or physically abusive to any Association staff member while they are at the pools performing job related tasks, the Ada County Sheriff will be called. We only mention it because it has happened in the past.

Please note, pool cards/fobs are issued by homeowner lot, therefore, ALL cards/fobs associated with the homeowner's lot will be turned off.
